Secura wins S\$4.9 million security services contract from Australian International School Pte Ltd

SINGAPORE, 27 April 2017 – Secura Group Limited (新保安集团有限公司) (“**Secura**” or the “**Company**” and together with its subsidiaries, the “**Group**”), one of the leading providers of security products, services and solutions in Singapore, today announced that Soverus Pte Ltd (新保安私人有限公司) (“**Soverus**”), its wholly-owned subsidiary, has been awarded a security services contract of approximately S\$4.9 million by Australian International School Pte Ltd.

The 32-month contract is for the provision of unarmed security services at the main campus of the Australian International School (“**AIS**”), and its campus for younger school children, the Early Learning Village (“**ELV**”), both located in Lorong Chuan. The contract is effective from 1 May 2017 to 31 December 2019 for ELV and 1 July 2017 to 31 December 2019 for AIS, with an option to renew for an additional two years thereafter.

Mr. Paul Lim (林春伟), Chief Executive Officer of Secura said, “Soverus has continued to build on its track record for effective and efficient security solutions to increase its market share in the security guarding industry. As we continue to see increasing demand for quality security guarding services on the back of rising security threats, we are well-positioned to capitalise on such opportunities as business and property owners look to strengthen their security infrastructure and capabilities.”

In January 2017, Soverus won a S\$6.7 million security services contract from SBS Transit DTL Pte Ltd, which is effective for three years from March 2017 to February 2020. This was followed by a S\$7.9 million security services contract from Singapore Telecommunications Limited which Soverus clinched in September 2016, effective for two years from October 2016 to September 2018.
