Secura makes first foray into China with security consultancy contract in Chongqing

- ***Secura to work with Raffles City Chongqing, an upcoming integrated development by CapitaLand***

SINGAPORE, 9 September 2016 – Secura Group Limited (新保安集团有限公司) (“**Secura**” or the “**Company**” and together with its subsidiaries, the “**Group**”), one of the leading providers of security products, services and solutions in Singapore, today announced that its wholly-owned subsidiary, Soverus Consultancy and Services Pte. Ltd. (“**Soverus**”), has been awarded a contract to provide security consultancy services to Raffles City Chongqing, an iconic upcoming integrated development in Chongqing, People’s Republic of China (“**PRC**”). This contract marks the Group’s first security consultancy project in the PRC.

Developed by CapitaLand China, a wholly-owned subsidiary of Singapore developer CapitaLand Limited (“**CapitaLand**”), Raffles City Chongqing is the largest single investment by a Singapore company in the PRC, and also CapitaLand’s largest integrated development in the PRC.

Under the contract, Soverus will assess the risks posed to the facility by criminal and terrorist threats, review and make recommendations to the security control measures and provide additional information including schematic drawings, mitigation measures, among others to enhance the security of the integrated development.

Mr. Paul Lim (林春伟), Chief Executive Officer of Secura said, “We are heartened to have secured our first security consultancy services contract in the PRC with a landmark development like Raffles City Chongqing. Being one of the largest and most visible developments in Chongqing, we believe this is an excellent entry point into the vast and growing PRC market for security services.”

“Chongqing has been attracting many high-end investment projects and is a growing economic centre in the Western China region. It is also the third government-to-government co-development project between Singapore and China, after Suzhou and Tianjin¹. With our strong expertise and product knowledge, we are confident of meeting the expectations of this project and add value to the development. This platform will be an ideal springboard to introduce our security consultancy expertise to the PRC market,” Mr Lim added.

Designed by internationally-acclaimed architect Moshe Safdie who designed Marina Bay Sands, Raffles City Chongqing is set to transform the skyline of Chongqing, with its scale and position at the confluence of the Yangtze River and the Jialing River. With a total construction floor area of approximately 1.12 million square meters, this iconic integrated development comprises a shopping mall and eight towers for residential, office, serviced residence and hotel use. The integrated development is expected to complete in phases from 2018.
